Janet "Dolly" Hannon, our clinician, was the Chair of the USDF Freestyle Committee, now part of the USDF Judges Committee, of which she continues as an active member. She has assisted in spearheading consistent freestyle scoring guidelines, which will be shared during this symposium. She is a USDF 4th-level certified instructor, "S" dressage judge, "R" Western Dressage judge and is on USDF Instructor Development faculty and the L faculty. Judges and auditors will learn how to enhance and improve freestyle quality for a variety of levels and stages of freestyle development.
