Treasurer's Report

Cindy shared the financials from the Michelle Combs Clinic:

- Profit from riders for \$800, 2 auditors for \$20,
- Costs: lunch was \$20.57, arena fee was \$300, clinician fee was \$520
- the loss was only \$20.57

### Schooling Show Report:

We had 42 rides but several scratches. It was a WDAA show and those scores have been submitted. We had \$1,380 in income. Expenses were: Arena \$300, \$400 for the judge, parking for judge \$39, flight was \$260, lunch was \$72, printing was \$63, WDAA for registration was \$35, total expenses were \$1,170. We made about \$210

We had decided as a club to charge for WDAA scores that were to be sent in and we forgot to do it on this show. This has since been corrected and on the next form for the show coming up at the end of April.

The tack swap made \$65 for the Education Fund

We have cancelled the June Clinic with Julie Haugan.

We are also trying to move the show from Saturday to Sunday, just waiting to hear back from Julie.

The show in Stanley in July is going forward. They have found a person to handle the whole thing. Maribeth will still do the entries and clipboards, but this person will pick all this up and the arena.

The judge for this show is Stacey Williams and this means that Stacey will be judging two shows in a row.
